2) The promotion of the above officials has been made on regular basis and will be subject to such terms and conditions of service as are applicable to similar class of employees as laid down in the ESIC (Staff and Conditions of Service), Regulations 1959 as amended from time to time. Regular promotion of officials at Sl.No.1 to 4, 6 to 9, 11, 12, 14 to 16, 20, 22, 24 to 26 shall take effect from 15-12-2011 and in respect of the officials at Sl.No.5, 10, 13, 17 to 19, 21, 23, 27 to 42 shall take effect from the date of reporting to the post of LDC.

3) The place of posting now ordered in respect of officials at Sl.No.5 & 40 is in public interest and are entitled to TA a per rules. They shall be relieved and instructed to report for duty at the new place of posting now ordered immediately.

4) Above Officials shall continue to draw pay at the minimum in the Pay Band of Rs. 5200-20200 with Grade Pay Rs.1900/- or existing pay, whichever is higher, pending fixation of pay under the rules, where necessary. The Officials, who are willing to exercise their option under FR 22(I)(a)(i), should do so within one month from the date of issue of this order.
