2) The above financial upgradation under MACP Scheme shall be subject to the terms and conditions mentioned in Govt. of India. DOP&T O.M.No.35034/3/2008-Estt.(D) dated 19.05.2009.

3) The pay on upgradation shall be fixed as per Para 4 of the Annexure I of the above mentioned O.M dated 19.05.2009. Benefit of pay fixation available at the time of regular promotion shall also be allowed and option for pay fixation under FR 22 I (a)(1) in the upgraded Pay Band/Grade Pay shall be exercised within one month from the date of issue of this order. The pay and date of increment would be fixed in accordance with clarification No. 2 of DOE's O.M.No.1/1/2008-IC, dated 13.9.08.

The financial upgradation is further subject to the conditions that:

a) No further fixation of pay at the time of regular promotion, if it is in the same grade pay as granted under MACP Scheme

b) However, at the time of actual promotion if it happens to be in a post carrying higher grade pay than what is available under MACP Scheme, no pay fixation would be available and only difference of grade pay would be made available. No additional increment will be granted at this stage.

4) The financial up gradation under MACP Scheme shall be purely personal to the employee together with retention of old designation and without conferring any privileges related to higher status.
