2) Promotions of the above officials are purely on adhoc basis without prejudice to the right of their seniors and shall take effect from the date on which they take charge of the promoted post. Adhoc promotion is for 90 days and they are further liable to be reverted at any time in the event of regular incumbents posted as per R.R. either through direct recruitment or through Limited Departmental Competitive Examination as may be ordered by the competent authority. Promotions on adhoc basis do not confer on them any right to seniority or for regular promotion. They will be governed by such terms and conditions of services, as are applicable to such employees under E.S.I. Corporation (Staff & Conditions of Service) Regulation, 1959, as amended from time to time. These officials shall draw the pay in the pay band of Rs. 9300-34800 + Gr. Pay Rs. 4600/-.

3) After accepting the promotions on adhoc basis, if any Assistant refuses/declines regular promotions later on because of the place of posting not being convenient to him/her, it will be construed as misconduct and departmental action will be taken against him/her.

4) In case of non acceptance of the promotions by any of the officials, he/she will not be considered for promotion for a period of one year from the date of refusal. In that event his/her junior(s) may start drawing higher pay and other benefits for which the senior(s) who has refused promotion will not be entitled to any relief in future. Non acceptance of promotion should be intimated in writing to Administration Branch latest by 18-1-2011

5) Transfer of the officials at Sl. No. 1, 9, and 12 are made in public interest and they are entitled to T.A./D.A. and joining time. They shall report at the respective place of posting (ie.) SRO Salem/Coimbatore/Madurai after getting intimation about their posting from the Sub Regional office Salem/Coimbatore/Madurai.

6) All officials shall submit relieving/joining/assumption reports as per orders to all concerned.
