2. Promotion of the above mentioned officials from sl. no. 9 to 23 are purely on adhoc basis without prejudice to the right of their seniors and shall take effect from the date on which they assume charge of the post of Asst. at the place of posting now ordered. They are liable to be reverted at any time on availability of regular incumbents or without any notice or assigning any reason whatsoever. The adhoc promotions do not confer on them any right to seniority or for regular promotion.

3. They will be governed by such terms and conditions of services as are applicable to such employees under E.S.I.C (Staff & Conditions of Service) Regulation, 1959, as amended from time to time. These officials shall draw the pay in the scale of Rs. 9300-34800 + 4200 G.P.

4. In case of non acceptance of the promotions by any of the officials, the same would be offered to their juniors, and consequently he/she will not be considered for promotion for a period of one year from the date of the refusal and in that event such junior(s) may start drawing higher pay and other benefits to which the senior(s), who has refused promotion, will not be entitled to any relief in future. Non acceptance of promotion should be intimated in writing to Administration Branch latest by 3-9-10. All officials shall submit relieving/joining/assumption reports as per orders to all concerned immediately.
