2. Promotion of above officials from Sl. No. 5 to 44 are made purely on adhoc basis without prejudice to the right of their seniors and shall take effect from the date on which they take charge of the promoted post. They are liable to be reverted to the post of LDC on availability of regular incumbents or at any time without any notice or assigning any reason whatsoever. The adhoc promotions do not confer on them any right to seniority or for regular promotion. They will be governed by such terms and conditions of services as are applicable to such employees under E.S.I.C (Staff & Conditions of Service) Regulation, 1959 as amended from time to time. These officials shall draw the pay in the Pay Band of PB-1-Rs. 5200-20200 with Grade Pay of Rs. 2400/-, subject to fixation of pay as per rules.

3. Transfer of the officials at Sl. No. 6 & 31 are on their own request and as such they are not entitled to TA/DA and joining time.

4. Promotion/Transfer of official at Sl. No. 39 is in public interest and he is entitled to TA/DA and joining time as per rules.

5. In case of non acceptance of the promotion by any of the officials, the same would be offered to the junior and, he/she will not be considered for promotion for a period of one year from the date of refusal. In that event such junior(s) may start drawing higher pay and other benefits for which the senior(s) who has refused promotion will not be entitled to any relief in future. Non-acceptance of promotion should be intimated in writing to Administration Branch latest by 3-9-10.

6. All the officials shall submit relieving/joining reports as per orders to all concerned immediately.
